Introduction

This book is written for the students of educational technology who wish to pursue their studies in English in order to benefit from and contribute to what is available in their areas of interest worldwide. It consists of 17 units, each concentrating on a particular theme or topic relevant to the needs and aspirations of these students. To develop or select appropriate materials, care was taken to consult subject matter professors and also authentic materials which appear on the web or in current textbooks and scholarly articles.

For the purposes of this edition, two new units discussing recent developments in educational technology, including the growth of e-learning and the pros and cons of the web, have helped enrich the previous edition. To make room for the new topics, a limited number of language tasks and activities were omitted from each unit.

Concerning the main features of the units, attempt has been made to include tasks and activities following each reading text to ensure better comprehension, vocabulary development, and also the consolidation of materials previously covered. Some of these activities include comprehension checks, word parts, word families, words in context, written and oral production of language, and also translation activities.

It must be admitted that since the web technology today is

expanding at a pace not so easy to keep up with, no textbook can cover all that is invented or developed on almost a daily basis, especially considering cost and time limitations. This book is no exception. I hope that students of educational technology will find the content, language and tasks provided in this book relevant to their expectations.

I am sure that this book, like many others, has its own shortcomings. Therefore, your criticisms, comments and suggestions for further improvement of the next edition will be greatly appreciated.
